## Community Ownership Funding available

The Community Ownership Fund is a £150 million fund to support community groups across England, Wales, Scotland, and Northern Ireland to take ownership of assets which are at risk of being lost to the community.



Round 4 is the final round of the Community Ownership Fund. There will be two bidding windows in Round 4 to allocate remaining funding. The fund forms part of a substantial package of UK wide levelling-up interventions building opportunity and empowering communities to improve their local places.

## Government Grants for Rural Community Buildings (England)

[ACRE](#) are pleased to be managing a grant fund on behalf of Defra to support the modernisation and improvement of rural community buildings.



A £3 million fund was originally launched by government in May 2022 to mark Her Late Majesty Queen Elizabeth II's Platinum Jubilee and in the 2024 Spring Budget, this was uplifted by a further £5 million. In 2023, over £1 million was awarded to groups with ambitious projects, many of which were concerned with improving the energy efficiency of buildings.

As far as multi-use spaces within Churches are concerned applications are welcome where there is not a village hall or other similar meeting place in the village. Similarly, some Church halls will be eligible. Applications are looked at carefully by the award panel so church applications will be given fair consideration.



- Any areas containing valuables should be locked to the general public.

### Duty to Manage Asbestos

### Is Your Health and Safety Law Poster Fake?

Only HSE can approve a version the H&S law poster. If you employ anyone, the law says you must:

- display an [approved version of the poster](#)

- provide each worker with a copy of the [equivalent leaflet](#).

You must display the poster where your workers can easily read it and you can't print a copy yourself. HSE is aware of suppliers selling fake versions online that haven't been approved. The current version of the law poster includes enhanced security features and is more durable. Read HSE's guidance on [how to identify a genuine law poster](#) and you can order a [HSE approved versions of the poster](#). If you have any doubts, you can [contact HSE](#) to check if the law poster is legitimate.


# Property Stewards' Handbook
