Cesar Anibal Guidi: Born in Buenos Aires, Argentina on 28 May 1944, and spent the first twenty-three years of his life there. After completing secondary education, Cesar entered the Faculty of Theology in Buenos Aires. From there he decided to become a volunteer for the World Council of Churches and was sent to Sicily for a year where he worked in a children's home in Palermo. It was with the 'Italian Team' and their regular retreats that he met Gill. In 1970 Cesar and Gill were married in Gill's home town of Harrow, and began their life together. The next year they were able to make their way to Argentina by ship, taking as many belongings as they were allowed. Cesar's first ministerial appointment was in Patagonia where he worked amongst the Welsh community. He was then moved a thousand miles north to minister to a small church community near the River de la Plata. When their first son Pablo was born the new family decided to travel back to England to visit Gill's relatives. It was about this time that the military government was in power in Argentina and things were very unsettled. Cesar decided to stay in England and spent several years working in nonchurch jobs. Their second son Robert was born in 1975. In 1982 Cesar applied to Wesley College to complete his ministerial training. He served in the following Circuits: Bristol (Frome Valley), Oxford, Newquay, Perranporth and St.Agnes, and Watford. He retired to Amersham but eventually moved with Gill to Ormskirk to live near their oldest son, Pablo. In his retirement amongst his hobbies he enjoyed singing with the local community choir, cooking and running the local U3A Philosophy Group. He was much missed by family in the UK and in Argentina with whom he kept close contact. An Argentinian hymn was sung at his funeral: "Heaven is singing for joy Hallelujah, for in your life and mine is shining the love of our God". Cesar died on 27 February 2024 in the eightieth year of his age and the forty-third year of his presbyteral ministry.

Martin Howard Wray: Born in Halifax on 21 July 1946. His father died when he was young and his mother and aunt helped to bring him up. He went to catering college and subsequently worked in the kitchens at Leeds University, and pubs in the Yorkshire Dales. His uncle Tom was a Methodist local preacher and Martin followed in his footsteps, eventually candidating for the ministry and, after acceptance, being sent for training at Wesley College, Bristol. Forming part of his studies was a period of two years at The Methodist Theological School in Delaware, Ohio with a placement in a local church there. Martin served in the following Circuits: Tonbridge, Gravs, Otley and Aireborough, Middlewich, Chorley, where he was superintendent minister, and Bolton. In 1998 he was given permission by the Methodist Conference to move into ministry in the sectors, giving him the freedom to develop his interest in spiritual direction, particularly drawing on the insights of St Teresa of Avila and St Ignatius Loyola. In 2010 Martin was invited to give an ecumenical perspective of St Teresa in a lecture to the International Teresian Conference in Avila, Spain. More locally, this next part of his ministry led to significant involvement at the Tabor Retreat Centre in Preston and Loyola Hall, Rainhill, Merseyside. Those post-1998 years opened a door, literally, Martin and Anne's house door, to many ministers and lay people from within the Methodist Church and beyond who came to benefit from Martin's wide reading, his profound sensitivity to the ebbs and flows of the human soul and his reminding them of the everlasting and unfailing mercies of God. For Martin, the joys of family were special. His wife Anne, children Laura, Tom and Melanie, and his grandchildren were held high in affection. At the time of Martin's death, Anne had been running for over thirty years a financial advisory service which proved helpful to many clergy. In his final years Martin became involved in the life of the parish church of Chorley and so it was fitting that Methodist, Anglican and Roman Catholic clergy took part in his funeral. Martin died on 23 April 2024 in the seventy-eighth year of his age and the fifty-second year of his presbyteral ministry.

# 3/16 ORDINATION SERVICES: SUPPLEMENTARY REPORT FROM THE FAITH AND ORDER COMMITTEE

- 3/16/1 The Conference received the following report:
  - 1. Ordination services are one of the highlights of the meeting of the Conference and are both solemn and joyful occasions as we celebrate God's gift of new presbyters and deacons to the Church. Ordinations in the Methodist Church take place on the Conference's behalf, at its direction and with its authorisation: no one else in the life of the Methodist Church holds such authority. This is an outworking of the corporate oversight of the Conference over all our ministry. As a result, the leadership of ordination services is different from leading any other act of Methodist worship. Our usual practice is that much is committed to those who lead our worship and preach: generally speaking, provided that what is done is not contrary to our doctrines those who preach and lead worship enjoy considerable creative freedom. However, because ordinations are acts of worship conducted on behalf of the Conference, those who take leadership roles within them do so in a particular representative capacity which signals the relation of what is taking place to the Conference. It is, therefore, expected that those who lead these services do not make alterations to their authorised texts.
  - 2. In the preparations for this year's Conference, it was suggested that the address to the congregation 'Sisters and Brothers' (no. 12 in both the ordination of presbyters and the ordination of deacons) be amended to provide for a gender-neutral form. The ordination services are authorised liturgies and there is not time for authorising a new form before the ordination services take place. Further, if amendments are to be formally made, there may be other matters also worthy of consideration. It is appropriate that

proper time and attention be given to this as part of the overall process of revising the *Methodist Worship Book*.

- 3. Nevertheless, the amendment suggested is in line with the Conference's strategy on *Justice, Dignity and Solidarity*. The words in question address the whole congregation gathered for an ordination service and a gender-neutral form would indicate more clearly the intention that it include all people, of all genders. The Faith and Order Committee therefore proposes, as an interim measure, that the Conference give permission for the President, or the President's deputy, presiding at any given service of ordination, at that person's discretion, to use an alternative form of words. The Committee proposes 'People of God'. This maintains a distinction from the form 'Beloved in Christ' at no. 13 which addresses the ordinands specifically.

As reported to the Conference, the Methodist Council in April accepted and referred to the Ministries Committee a recommendation from the Strategy and Resources Committee that there be a review of the provision for learning for ministry.

The Ministries Committee in May agreed terms of reference for the review:

- To note the criteria and competencies which have been agreed by the Conference.
- To review, and assess the efficacy of, the Connexion's work at Cliff College and the Queen's Foundation, in the light of the budgetary constraints, the changes in the HE sector since the 2017 HE Act, the priorities for training set by the Conference, especially in the 2021 reports Ministry in the Methodist Church and Changing Patterns of Ministry, and the circumstances in which ministry is exercised in the mid-21st century.
- To review any agreements that the Council has made with other institutions, both in the delivery of learning for ministry and in the generation of revenue.
- To note the role of the newly introduced Connexional Learning Forum.
- To review the collaboration between the institutions and the Connexional Team (principally but not solely the Learning Network) in the delivery of training for lay and ordained ministry.
- To make recommendations to the Ministries Committee for report to the Connexional Council and the Conference.

The Committee also discussed how this work should be reported. Noting that this is primarily a review of the resourcing of the provision (and that finance and governance have been the key factors in its initiation), the committee agreed that the Connexional Council would need to receive regular reports and that the Conference should be kept informed. The committee therefore directed that the review be directed to report to the committee in February of next year (which would subsequently be reported to the

Connexional Council) and to ask that the 2025 Conference receive a progress report including such recommendations as might have emerged at that point.

Members of the Conference might be aware that the Team is currently in the process of recruiting to the post of Director of Learning for Ministry (DLM); the process of and support for the review will be agreed with the appointee and the Ministries Committee will keep the Council updated on progress. The committee agreed to the appointment of a consultant for this work but the detail of this will need to be worked out by the new DLM.

The Conference is assured that those responsible for the review will be directed to ensure that there is full consultation with all the institutions involved.

# 5/7/1 Report from the Law and Polity Conference Sub-committee

1. At the time item 24 was included in the Agenda it was believed that, as stated in paragraph 3, the proposed Model Trust amendments referred to in the report had been submitted to the Channel Islands, Isle of Man, Scotland and Shetland Synods for consideration as required by Standing Order 126(1)(a). Unfortunately it transpired that, through illness, that had not been done and the omission had not been

appreciated until after the relevant spring Synods. The Law and Polity Conference Sub-committee has considered how best to deal with the situation which has therefore arisen.

2. The Sub-committee's advice is that, in the light of that omission, it would not be appropriate to bring the proposed amendments to the Conference for confirmation this year. The Sub-committee therefore proposes to seek the permission of the Conference to withdraw the resolution in Agenda item 24. Instead it proposes that alternative steps should be taken, as follows.

3. The Model Trust amendments set out in paragraph 9(A) and (B) of item 24 were proposed as consequential upon the decisions taken by the Conference relating to the establishment of the Connexional Council. The amendments in (A) effectively replace the definition of "Methodist Council" with a definition of "Connexional Council" and then substitute "Connexional Council" for "Methodist Council" in the specified paragraphs of the Model Trusts. If the amendments are not confirmed this year, the definition of "Methodist Council" will remain in place and the substitutions will not be made. The Methodist Council, however, is defined as "the body of persons of that name for the time being constituted by the Conference under the Deed of Union and Standing Orders for the despatch of connexional business ...". As from 1 September 2024 the Deed of Union will not itself constitute any body as the Methodist Council and, if resolution 50/5 is passed and the relevant Standing Orders are revoked, there will be no body so constituted. This has some similarities with the situation resulting from the abolition of the Property Division and the office of Property Secretary, which was addressed by Standing Order 331. It is suggested that in the present case there should be a new Standing Order to the effect that the functions, duties and responsibilities assigned to the Methodist Council by the Model Trusts shall be exercised and performed by the Connexional Council.

4. If the amendments in (B) on page 302 are not made, the Conference will continue to appoint the Conference trustees of Conference property, but could delegate the exercise of its power to the Connexional Council under clause 21 of the Deed of Union with effect from 1 September 2024. (The Conference is already being invited to exercise its power of appointment this year by resolutions 46/22 and 46/23.) The definition of "Connexional Trustees" will continue to refer to the persons constituting the connexional trustees for the relevant property in accordance with Standing Orders. The Sub-committee suggests that SO 904 should be amended to identify the Connexional Council as the connexional trustees. (The new Standing Order proposed in 3 above could appear here also, under a revised heading.) This would be consistent with the work which has been done on references to the Connexional Council in Part 9 and which appears elsewhere on the Order Paper.

5. The issue arising in relation to resolution 42/5 amending Model Trust 26 is obviously much less significant. The Sub-committee thinks, however, that since MT 26(1) does not oblige anyone to execute a memorandum of consent and (3) and (4) are on the basis that there will be a memorandum, the Conference could direct that, since such memoranda no longer serve a useful purpose under the law of England and Wales, no further memoranda should be executed in that jurisdiction. That should remove the administrative burden without requiring an amendment to the Model Trusts.

6. The Sub-committee suggests that the relevant business be brought again this year in the form in which it was brought in 2023, so that the two year period starts

running again. The definition of "special resolution" in section 2 of the Methodist Church Act 1976 makes clear that confirmation must take place in the year following the year in which the resolution making the amendment was first passed, so it is not possible simply to bring the resolutions of 2023 to the Conference of 2025 for confirmation.

7. The special resolutions passed by the Conference of 2023 are also the subject of Section E of Agenda item 49, partly by way of cross-reference to Agenda item 24 and partly by way of inadvertent duplication. The Sub-committee proposes to seek the permission of the Conference to withdraw the resolutions in Section E.

#### Introduction

The purpose of this monitoring is to gain an understanding of the gender distribution of speakers, giving an insight into issues of inclusion and representation. This report covers data collected on 1st July 2024. Further analysis will take place post Conference.

Data were collected by volunteers who recorded the gender of speakers as described on their name badges and whether speakers were Lay or Ordained for each session. Tally sheets were compiled and analysed to provide an overview of gender diversity.

# 6/18/5 SUMMARY REPORT OF THE JUSTICE, DIGNITY AND SOLIDARITY SCRUTINY GROUP TO THE CONFERENCE

The JDS Scrutiny Group has continued to meet together during 2023/2024 and has also met with the Secretary of the Conference and the Connexional Secretary and with the Co-Chairs of the JDS Committee and the Director of Inclusion.

We are pleased that there has been movement on JDS strategy related issues during the year whilst recognising that some things have not been able to move as quickly as would have been wished due to the Implementation Officer role ending last summer and the new JDS Programme Co-ordinator not being able to be in post until this September. A detailed project plan has not yet been produced and therefore robust project management of the delivery of the JDS strategy is not yet in place. We continue to believe that the project plan will support the JDS Committee and ourselves in ensuring that the strategy moves forward in a timely manner with appropriate scrutiny.

We were pleased to see the report of the Susanna Wesley Foundation research carried out to explore awareness of and progress in implementing the Methodist Church's JDS strategy. It revealed that the strategy is welcomed but hardly off the ground in most local churches. They make a number of interesting points such as "Methodist culture blocks progress; whilst many Methodists would want to be working within a JDS approach, the culture of not wanting to make mistakes or change beloved ways of doing things mitigate against it happening. They say that "a greater sense of priorities and stages towards implementation is needed". They also recognise that "it may take many years for the Church to feel significantly different unless there is more connexional clarity and guidance on the steps to take in order to move forward".

The Susanna Wesley report also sets out that a joined up approach is needed; "existing connexional strategies and policies including safeguarding and "God for all" need to be harmonised with the JDS approach (and vice versa)". Whilst recognising that there has been progress on developing such an approach, and on recommended work related to worship resources, we look forward to seeing further progress on these and other aspects of this helpful report.

We hope that discussion on the practical outworking of the structures as set out in the Trustee and Oversight work will be able to facilitate the needed joined up approach further. There has been some movement on this as set out in the JDS Committee report, but we hope that going forward the JDS awareness in all major policies of the Church including the ongoing stationing review and the outcomes of the review of part 11 of Standing Orders (Complaints and discipline). There is mention of the DARS programme in the Part 11 report but there is not clarity about how it would be integrated with all complaints including safeguarding although we understand that the Director of inclusion has been working with colleagues around safeguarding and Part 11 and we hope to see the connections made clearer. In adopting the resolutions in the Part 11 review report it would have been helpful to have spelled out which complaints - from Part 11, safeguarding and DARS will be included in the record management, case management and reporting systems and a simplified 3 tier model for addressing complaints (Recommendations 5, 6, 7 and 8) There has been active engagement with "Justice seeking church" and "God for all" colleagues and we look forward to this continuing. There has also been collaborative working with the Learning and Development team, and it is good to see training being encouraged and delivered around the Connexion including the EDI induction and the mandatory training. The work being done in Districts is also encouraging although standard record keeping would enable the Church to have more assurance about the training and other work being carried out. In relation to the Conference we welcome the proposal in part 2 of the Methodist Council report section T that on the recommendation of the JDS Committee the equality impact assessment will be incorporated alongside the Notice of Motion form to ensure issues related to discrimination can be actively considered and prevented. We look forward to the further work being considered to ascertain the reach and impact of the JDS strategy.

Unfortunately, there has not been an opportunity to have a meeting with representatives of the Oversight and Trusteeship Task Group (OTTG) who we know have had an enormous workload in looking at all the things which needed to be brought to the Conference this year. This means that we have not been able to follow up on the concerns we expressed in our report last year about how the JDS Committee will be able to exercise its responsibilities in Standing Orders under the new reporting arrangements, that is via the Mission Committee. No consultation was able to take place with the JDS Committee either. The difficulties around this are not covered in the latest Oversight and Trusteeship report. The SO re the Mission Committee does not set out its role in relation to the implementation of the JDS strategy or in ensuring that the JDS Committee has all the information that it needs in order to for example "Make strategic recommendations and give support and guidance to the council in all matters relating to equality, diversity and inclusion" (SO 330(2)(i)). We note the careful consideration that the Mission Committee has given to other areas of its responsibility and are aware that it takes its own responsibilities with regard to JDS matters seriously. We are, however, disappointed that the JDS Committee Chair is not on the Connexional Council alongside the Chairs of the Mission, Ministries, Resourcing and Audit and Risk Assurance Committees as JDS matters are integral to all of the work of the Church - trusteeship, ministries and resourcing as well as mission. It has been agreed that conversations will need to take place to ensure that all the affected bodies have a shared understanding of the way forward and any subsequent proposals for changes to reporting or Standing Orders brought to the 2025 Conference. This may be the kind of thing that the Task Group envisage when saying in their report that "All Committees, working parties and task groups will need a "Ways of Working document". We would be happy to be part of such discussions. We hope that such conversations will also include SO 221 related to the scrutiny group.

In summary we reflect further on these words from the Susanna Wesley report that "implementing the JDS strategy is both an important and difficult task" and look forward to further progress during the coming year.

#### Report

- 1. Under the present Articles of Association, any amendment requires the consent of the Conference which is to be evidenced by a resolution signed by the President of the Conference. The Law and Polity Conference Sub-committee, having considered a complete copy of the Articles containing the proposed revisions in draft form, is able to advise the Conference that the report at Agenda item 13 sets out at pp 60-62 the new form of the individual articles which will result from the proposed revision. For completeness, the Subcommittee draws to the attention of the Conference the fact, as there are no longer any schools falling under the definition of "Acquired Schools" (see the report at p 60) it is proposed to delete from article 2.2 the words "or Acquired School and to act as member of any Acquired School", from article 16.2 the definition of "Acquired Schools" and from Schedule 1 the words "and Acquired Schools" in the title (which will read "The Schools and Associated Schools" as shown on p 61) and Part 3, listing the Acquired Schools.
- 2. The report in item 13 helpfully explains that the revisions are intended:
- 2.1 to allow for the appointment of up to 17 Trustees (see the revised articles 3.2, 3.4.3 and 3.4.5 (the existing article 3.4.5, providing for a Connexional Representative Trustee, being deleted). This is a net increase in the maximum number of Trustees from 16 to 17 and is accompanied by an increase in the minimum number of Trustees from 10 to 11;

- 2.2 to reduce the minimum proportion of Trustees who must be Methodists from one half to one third (again see the revised article 3.2);
- 2.3 to reflect the preference expressed on behalf of the Methodist Church that there should no longer be a Connexional Representative Trustee but rather a Connexional Representative with the right to attend Trustee meetings and to speak but not to vote (see the revised articles 3.6 and 3.8.7, removing provisions relating to the Connexional Representative Trustee, the new article 4.9 and the new definition of "Connexional Representative" in article 16.2, by amendment to the previous definition of "Connexional Representative Trustee"
- 2.4 to cover "housekeeping" points resulting from the fact that there are no longer any Acquired Schools.
- 3. The Sub-committee notes that the numbering of the new article 4.9 results from an amendment to article 4.7, which has been divided into articles 4.7 and 4.8 so that the attendance of Heads at Trustees' meetings is dealt with in a separate article from the attendance of the General Secretary and the Business Director of MIST. It further notes that there is additionally a new article 4.10, as shown on p 61. The existing 4.9 therefore becomes 4.11.
- 4. The Sub-committee does not perceive any difficulty with the principles of the revisions outlined above, but draws attention to the following points.
- 5. First, by way of clarification, "Chairs of Governors Trustees" is a term defined in article 16.2 to mean Trustees appointed on the recommendation of the Chairs of Governors (or as there set out). The Trustees do not themselves have to be Chairs of Governors.
- 6. Secondly, the existing articles contain in 16.2 a definition of "Methodist Council Trustees" as Trustees appointed on the nomination of the Methodist Council and the existing article 3.4.3 provides for the appointment of five Methodist Council Trustees. Although the report at p 61 refers to "Connexional Council Trustees" in a revised 3.4.3, no definition of "Connexional Council Trustees" is proposed and there is no proposal to delete the definition of "Methodist Council Trustees". The Sub-committee's understanding is that the Connexional Council Trustees are to be nominated by the Connexional Council, so that effectively the Connexional Council will replace the Methodist Council in this context. This will require further amendments to the Articles of Association, as reflected in the revised resolution 13/2 set out below.
- 7. Thirdly, in the Sub-committee's view the Connexional Representative should be nominated by the Connexional Council rather than "the Methodist Church" and an amendment to the definition on p 61 is therefore proposed, again as reflected in the revised resolution 13/2. It is assumed that "or" at the end of line 2 of the definition of "Connexional Representative" is a typographical error for "for".
- 8. Finally, the Sub-committee understands that Shebbear College has been sold and therefore should be deleted from Schedule 1 Part 1.
- 9. The Sub-committee advises the Conference that it can properly consent to the proposed revisions to the MIST Articles of Association subject to the further revisions identified above.

The data revealed 35 male speakers, 36 female speakers, 1 non-binary speaker and 4 speakers preferred not to state their gender. Speakers who were lay: 28 (37%), ordained: 48 (63%).

Because of absences, there have been 220 representatives at the Conference. 117 female representatives, 87 male representatives, 2 non-binary representatives and 14 representatives who preferred not to state a gender.

There were a total of 113 ordained (51% of representatives) representatives and 107 lay (49% of representatives) representatives.

#### 7/7/3 Supplementary report

As a result of the further consultation and consideration referred to in Section 7, three areas have been addressed:

1) The definition of "parent body": it is proposed that the Connexional Council be excluded from the definition in SO 907, as the provisions relating to parent bodies are not appropriate for application to the council in its trustee body role. The amendment to SO 907 and the consequential amendments in Section 91 below deal with this point.

2) The appropriate requirements to apply to the Connexional Council where the council proposes to carry out projects on connexional property of which it has the managing trusteeship: it is recommended that the council be exempted from the normal consent requirements in SO 930, again because of its particular trustee role in our governance structures, but that there be a new SO 931A which lays upon the council some requirements as to consultation as set out below.

The exception to this exemption is where the project involves work being undertaken which falls within the compass of Section 98 ("Listed Building Works"). In this case, it is essential that the church is able to demonstrate, for the purpose of retaining its ecclesiastical exemption from local planning authority control, that there is a robust consent system (including provision for reviews and appeals). The new SO 986 lays down how this system, working through the Listed Building Committee, shall apply to the council.

3) A very minor amendment of the Model Trust Consultation Regulations is proposed to reflect the constitution of the Connexional Council.

Further amendments to Part 9 appear elsewhere in the Order Paper in relation to the Special Resolutions, but the adoption of those amendments does not affect the proposals set out here.

All the amendments set out below form part of Appendix B, proposed for adoption in Resolution 50/6 and accordingly are to be understood as appearing in Section 7 on page 655 of the Agenda.

# 7/24/2 ADDENDUM TO THE REPORT

## Ecumenism in Scotland National Ecumenical Body in Scotland

For several years, work and discussion have been on-going around the future shape of the ecumenical landscape in Scotland and, within this, the place of Action of *Churches Together in Scotland* (ACTS) and the Scottish Christian Forum (SCF). Following the gathering of ecumenical stakeholders on 16 January 2023, the Scottish *Ecumenical Officers Forum* (EOF) was charged to undertake further work, and to report back in the autumn of 2023. At the further meeting on 28 November 2023, stakeholders agreed to proceed with work to make the SCF the National Ecumenical Body within Scotland, and tasked the EOF to prepare more detailed plans. At a further gathering of Scottish ecumenical stakeholders on 6 February 2024, the consensus between the churches and traditions involved in the SCF was reached to proceed with the plans as outlined in the Appendix below. The process of working together across boundaries has been one of finding a consensus and common mind, yet also leaving space for the work to develop.

This change was supported by both the Shetland and Scotland Districts at their spring Synods in 2024.

# Appendix

# Scottish Christian Forum

# Vision:

- 1. The vision for the Scottish Christian Forum is rooted in the belief that the Holy Spirit is calling the churches, inter-church and Christian organisations in Scotland to a pilgrimage of greater unity, cooperation and common witness. The Forum will create an open space where respectful conversation between leaders and representatives from these bodies can take place.
- 2. The vision is inspired by a renewal of the call to prayer and our common witness to the Gospel. Embracing this vision will lead to the deepening of a shared spirituality; support for ecumenical initiatives at all levels; and the exploration of common challenges. It will foster ecumenical relationships which respect the variety of Christian life and witness in Scotland and encourage participation in the shared life of the Church.
- 3. The foundation of the Forum is mutual respect, acceptance and attentive listening, allied to the recognition of diversity among the participants, The Forum will seek to discern the work of the Holy Spirit and to respond in an ecumenism of action. Implicit in this is the recognition that participation will not require any church or organisation to abandon particular theological perspectives or traditional religious identities. Participation is to be understood theologically, whereby it is acknowledged that all participants are members of the Body of Christ (1 Corinthians 12:12-31).

# **Constituent Elements:**

The constituent elements of the Scottish Christian Forum, in the first instance, are the Scottish Church Leaders' Forum and the Scottish Ecumenical Officers' Forum. As the Forum evolves it is anticipated that other forums will develop and become an integral part of the body.

## National Ecumenical Body:

The Scottish Christian Forum will be designated the National Ecumenical Body, and will relate as such to the other ecumenical instruments within Britain and Ireland through the Scottish Ecumenical Officers' Forum.

Appeal raised by the South Holland Circuit 17/15 against the decision not to authorise Darren Charlton to preside at the sacrament of the Lord's Supper in the South Holland Circuit.

The panel was grateful to the Circuit for their submission and the extra information that it contained.

The panel recommends to the Conference that the appeal be upheld and an authorisation granted, on the following grounds.

- The Authorisations Committee had accepted that there was a proven need in the Circuit for an authorisation to be granted to someone. The additional information in the appeal made it plain how great and urgent that need is.
- The Panel noted that the Circuit had not been able to find an alternative candidate to fulfil the role as suggested by the Authorisations Committee.
- The Panel noted that the Criteria for Authorising Persons in these matters in CPD state that if it is judged that the granting of an authorisation to a particular person might lead to a blurring of the distinction between particular calling and ministries, the Authorisations Committee might decline the application, but that it is not required to decline it. Although there was a hint in the original application that blurring might be taking place, the Panel accepted the assurances in the appeal submission that this was not the case, and trust that there will be education in the circuit to re-enforce this.
- The Panel judged that the need in the circuit was such that the appeal should be upheld.

On another point, the Panel noted that this was the first year that new Criteria were applied and felt there was a lack of clarity, particularly regarding what constitutes a blurring of the distinction between particular callings and ministries. The Panel believe that there is a need for more guidance to be given to circuits about how to make an application, and what information would be helpful for the circuit to provide.

# 7/43/1 **3.** Overlapping business

3.1 The Conference will be aware that it has at times dealt with business which involved amendments to Standing Orders which were also amended by resolutions contained in Agenda item 50, the report of the Oversight and Trusteeship Task Group. It may assist the Conference to bear in mind that, in the absence of any contrary direction or resolution, its resolutions take effect from the date on which they are passed. Accordingly, where the Conference has amended Standing Orders which were subsequently amended by Resolutions 50/5 and 50/6 taking effect from 1 September 2024, there is no inconsistency between the two sets of amendments. The first amendments will have effect until 1 September 2024, after which the second set of amendments will take effect.

3.2 This principle means that following the adoption of resolutions 50/5 (revoking Parts 2, 3 and 10 of Standing Orders and replacing them with Parts 2 and 3 as set out in Agenda item 50, as amended on the Order Paper) and 50/6 (making consequential amendments), taking effect from 1 September 2024 in accordance with Resolution 50/9, the position in relation to that business is as follows:

- The business relating to modified constitutions of districts in Agenda item 3, Methodist Council part 1, Section C, (Resolution 3/5) contained amendments to Standing Orders 401 and Section 48A referring to the Connexional Council on the assumption that Resolution 50/5 would be passed. No further amendments are required.
- 2) Agenda item 22, Methodist Council part 2, Section K, dealing with discretionary payments to circuits amended Standing Orders 013 and 1105 (Resolution 22/12) but retained unamended in each case a cross-reference to Standing Order 365(7), which by virtue of Resolution 50/5 has become Standing Order 376(6). The cross-references will be corrected during the editing of *The Constitutional Practice and Discipline*, as provided for by resolution 50/7 as amended. The new Standing Order 376(6) was adopted in the revised form set out on the Order Paper, including at the end of paragraph (i) the words "or Standing Order 1105(10)". No further amendments are required.
- 3) The revisions to the Standing Orders governing the Forces Board in Agenda item 22, Methodist Council part 2, Section 0, (Resolution 22/19) were drafted on the assumption that Resolution 50/5 would be passed. No further amendments are required.
- 4) The principle that the role of Connexional Treasurer should cease to exist was reported to the Conference in Agenda item 22, Methodist Council part 2, Section R (Resolution 22/25), and the consequential Standing Order

amendments there referred to are set out on pp 648-9 and were made by Resolution 50/6. No further amendments are required.

- 5) The Methodist Council's expectation that the current Standing Order 212(5), providing for the Medical Committee, would be revoked and not replaced was reported to the Conference in Agenda item 22, Methodist Council part 2, Section S (Resolution 22/26). Standing Order 212(5) was duly revoked by Resolution 50/5. No further amendments are required.
- 6) The business relating to the Conference Scrutiny Sub-committee in Agenda item 22, Methodist Council part 2, Section T, contained amendments drafted on the assumption that Resolution 50/5 would be passed. No further amendments are required.
- 7) The business relating to the composition of the Conference in Agenda item 49, Committee on Methodist Law and Polity, Section D, contained amendments to Standing Order 102 on the assumption that Resolution 50/5 would be passed, but also included a minor change to the current Standing Order 250. That change is superseded by the revocation of Standing Order 250 with effect from 1 September 2024 and its replacement by a new Standing Order 240, the text of which was considered and adopted as part of the business in Agenda item 22, Methodist Council part 2, Section G (see Resolution 22/4 [at 6/18/2], cross-referred to in Agenda item 50 at p 603).
