- 1. The Methodist Council has had a productive and heartening year fulfilling its responsibility of keeping the life of the Methodist Church under review and proposing to the Conference changes which will make the Church's life, work, mission and worship more effective in sharing God's mission and giving glory to God. Led with a light touch by its new Chair, the ex Vice-President David Walton, it has given spiritual leadership to the Church graciously and in good humour, even when under pressure. It has done so in a way that is rooted in worship and prayer as it has sought to discern and articulate a vision of what being a body of followers of Christ who are called to serve the present age might require of us all.
- 2. Members of the Council are representatives of various officers and bodies in the life of the Church to the Council; and equally representatives of the Council to those bodies. The responsibilities of the Council and what can be expected of its members are summarised in the paper *Expectations of Various Groups* at the start of this Agenda.
- 3. The full range of papers presented to the Council and the outcomes of the Council's deliberations on them have been available on the Church's website during the year (www.methodist.org.uk). This report mentions some of the key themes and issues that the Council has addressed during the year. It also indicates some other issues which it has addressed that are not presented to the Conference for the Conference to make its own judgement; and outlines the other actions taken by the Council, within the powers allocated to it by the Conference.

In what follows * indicates that the fruits of the Council's work are presented elsewhere in the Agenda of the Conference.

Key Themes and Issues

- 4. Not all the Council's deliberations were directed towards the inward workings of the Church. The Council heard with concern of the situations in Fiji and Haiti. Considerable time was spent during the year considering whether a new Statement on Abortion* was required, and on matters to do with Israel-Palestine*.
- 5. Within the life of the Church, there were reports on Safer Recruitment*; Safeguarding Vulnerable Adults*; Safeguarding Children; Personnel Files for Presbyters and Deacons*; Early Retirement for Presbyters and Deacons through ill health*; Pension costs and benefits*; and the Review of Committees*.
- 6. The Council also received reports from a working group looking at the topic of *One Connexion: Many Nations and Jurisdictions*. The group highlighted issues of a lack of clarity about what it means to be "connexional"; a tension over whether the Methodist Church is at heart an institutional church or a movement; questions of subsidiarity (i.e. where power resides); and difficulties over dealing with different statutory regimes, languages and cultures. It pointed to two images that might be helpful in dealing with these issues: the Connexion as a diverse collection of people journeying as pilgrims; and as being members of one family, giving and receiving hospitality. The Council thanked the group for its work; asked the Faith and Order Network to take up the issues of how the nature and mission of the Church are experienced and expressed in Methodism today; asked that workshops be held for members of the Connexional Team to raise awareness of these matters, particularly the jurisdictional ones; and recommended that the *Belonging Together* partnership seeks to address the issues around church fellowships operating in different languages.
- 7. Following the consolidation of connexional grant-making into a single system of inter-linked processes and the formation of a Connexional Grants Committee, the Council agreed on some strategic guidance for that Committee. These were to the effect that the Council would not dictate how much of the funds available to the Committee from general funds should be spent on the various areas of the Church's work through the various grant-making "streams"; the Committee should give suggested guidance on spending for the various "streams" in

tandem with the Council's budget-making process; special criteria and processes should be developed for dealing with Chaplaincies; and application-based research projects should not be funded by this route.

- 8. The Council had a long and careful discussion of the Review of the Resourcing Mission Office, currently located in Manchester, which formed the last major part of the Team Focus process. Members of the Council were sensitive to dealing with the feelings of members of the staff and others in the connexion, as well as varying perceptions of the needs of the Church. The Council unanimously expressed its gratitude to the staff of the Resourcing Mission Office for the work they do and the way they had co-operated with the review process. After alternative proposals were considered which failed to reach a majority, the Council voted by a two-thirds majority that specialist areas of property work (conservation; listed building; landfill grants etc.) should remain in Manchester; a new post of Connexional Property Co-ordinator should be established in the Team based in Methodist Church House, together with posts dealing with property grants, finance, governance and database management. Further discussion of these matters can be found in a reply to a Memorial on the subject elsewhere in the Conference Agenda*.
- 9. There was a similarly long, careful and prayerful discussion about the future of Wesley College, Bristol*. With regret, the Council agreed by over a 75% majority to recommend to the Conference the closure of the College.
- 10. The Council gave further consideration to the uses of "discipleship" as a focussing theme for the mission of the Church and the work of the Connexional Team and others. The Council also reviewed the work undertaken by the Team in 2008–9, and prioritised the work to be undertaken by the Team in 2009–10. Throughout the year growing unease was expressed about the sheer volume and strain of work coming on all the governance bodies of the Church and also the Connexional Team. The Council asked that this be brought to the attention of the Conference. The officers of the Council and the Strategy and Resources Committee are to consult others and bring recommendations about possible ways forward to the Council in the coming connexional year.

Governance responsibilities

- 11. In accordance with its governance responsibilities, the Council:
- 11.1 gave consent for resolutions to be presented to the Conference for the leasehold transfer of Southlands College to Roehampton University and associated changes in governance arrangements*;
- 11.2 agreed that the Iberian Estate Company and the Primitive Methodist African Missionary Society be wound up;
- 11.3 approved a Memorandum of Understanding between Christian Aid, MRDF and the Methodist Church;
- 11.4 delegated responsibility as managing trustees for 4 John Wesley Road, Peterborough to the Strategy and Resources Committee;
- 11.5 approved interim arrangements for the Epworth Press*;
- 11.6 appointed a Connexional Reconciliation Panel;
- 11.7 appointed a group to consider the processes connected with presidential enquiries;
- 11.8 approved the terms of reference and additional names for the reconfigured Music Resources Group:

- 11.9 noted decisions taken by the Strategy and Resources Committee to improve the governance scrutiny procedures;
- 11.10 co-opted additional members to the Ministerial and Diaconal Candidates Selection Committees;
- 11.11 approved an amendment to the scheme for the Leys and St. Faith's schools;
- 11.12 appointed additional members of the Connexional Grants Committee, its sub-committees and its "streams":
- 11.13 made sundry other appointments in its own right, and nominations and re-nominations to the Conference*:
- 11.14 approved the Special Resolutions from the 2009 Conference;
- 11.15 approved a Homeworking Policy for Methodist Council employees;
- 11.16 approved a Memorandum in respect of the Wesley Study Centre, Durham;
- 11.17 resolved to make an application to become a member of ROOTS for Churches Limited;
- 11.18 recommended to the Conference revised financial reporting procedures*;
- 11.19 received reports from committees and trustee bodies which are accountable to the Conference.

Other Business

- 12.9 the size of circuit meetings and managing trusteeship;
- 12.10 the Methodist Heritage report*;
- 12.11 the creation of the new authorised collection of hymns and songs, Singing the Faith, and the rolling resource of additional material*;
- 12.12 work on the missing generation* and youth participation*;
- 12.13 recommendations about appeals to the Conference in discipline cases*.

ANNUAL REPORT AND FINANCIAL STATEMENTS FOR THE YEAR 2008-9

13. Standing Order 360(1) states that:

The Methodist Council shall submit to the Conference annually a unified statement of connexional finances, clearly distinguishing between restricted and unrestricted funds and conforming to the law and accounting regulations, so as to give an overall view of those moneys and other assets for which the council is responsible.

14. The Consolidated Annual Report and Financial Statements of the Methodist Council for the year ended 31 August 2009 fulfils this requirement. The Council at its meeting on 10–12 April 2010 approved the report and authorised that it be signed on its behalf.
