The Trustees, three ministers and three lay persons appointed by the Conference, act as trustees under the terms of a Trust Deed of 10 October 1924 for a number of connexional funds and properties.

A summary of the income and expenditure account and balance sheet, based on the audited accounts, is shown below by way of report. In addition the Trustees received and duly paid to the funds concerned dividends and other income of approximately £11,355,000.

Two new Trustees are proposed below.

The continuing Trustees are Revd Dr Stuart Jordan, Revd David Gamble, Mr Philip Bedford-Smith and Mr Christopher Linford.
