Church demand Edwardes College back from the Government

Edwardes College, Peshawar is one of the and Provincial Chief Minister at that time oldest and prestigious institutes of the Province. The Church Missionary Society established the Church Mission College in 1900 as an outgrowth Edwardes High School, Kohati Gate, Peshawar City, which, at been founded in 1855 by the society as the first educational institution in the North West Frontier region of what was British India. For many years the college was the only institution of higher education in the North West Frontier .Sir Herbert Edwardes was a British colonial administer and commander whose name the college later adopted.

CMS looked after the College for a long time through a Board of Governors with the Bishop of the Lahore as the Chair. The College runs under its own constitutions approved by the then Board in 1943. After the creation of the Peshawar Diocese in 1980 control of the Edwardes College came under the Peshawar Diocese however the properties belong to the Lahore Diocese Association. It is worth mentioning that almost 90% property of the College was bought during the passage of time and different accommodation, hostels and blocks were added to the College. In 1972 Mr. Zulfqar Ali Bhutto, Prime Minister and the Chief Marshal Law Administrator nationalized all the private Educational Institutions with an immediate effect. However, Arbab Sikander Khan Khalil the Provincial Governor, member National Awami Party (NAP) and Mullana Mufti Mehood (father of Mullana Fazal-ur-Rehaman) Head of the Jamiyat-i-Ulma Islam

forced the Federal Government not to nationalize the private institutions especially the Christian Educational Institutions in the Frontier Province Khyber Pakhtunkhwa). The Federal Education Minister Hafiz Pirzada in 1972 clearly said we are considering the request of the Provincial Government thus the College was never nationalized. In 1973 the constitution of the country was implemented thus the Martial Law orders automatically came to an end. In 1974 to further secure the Independent status of the College, the Provincial Governor through a notification formulated a new Board of Governors but it had no legal backing. The Provincial Law Department and the Education Department confirmed that the College was never nationalized and stands as a Private Institution.

In 2016, the High Court Peshawar responding to a writ petition against the appointment of the College Principal declared that the Board of Governors formulated in 1974 has no legal standing thus stood dissolved. The Provincial Government went into an appeal against this decision but withdrew as the High Court judgment was taken to the Supreme Court of Pakistan. In 2018 the Apex court dismissed the case as not pressed; it was further confirmed that the College was never nationalized. In March 2019 after having informed both the

Provincial and the Federal Governments and the high officials the Diocese of Peshawar as per the College constitution 1943 and on the basis of the Courts' judgment 2016 installed the Board of Governors as it was before 1974. The Prime Minister, Pakistan acknowledged the formation of the new board with best regards. Instead of accepting the Courts' decisions and the formation of the new Board of Governors, the Provincial Government of KPK started interfering and pressuring the College administration. Against this pressure the Bishop of Peshawar took a stay order against the Provincial and the federal Governments. The Provincial Government through its Chief Secretary, Education Secretary and the Governor's Principal Secretary launched a court case against the Bishop of Peshawar. This is the first time in the history of Pakistan that the Government has gone against the Church. The case was decided in the favor of the Government, the High Court set aside its own decision of 2016 with the most surprising point that the Church Trust property also stands nationalized. It is worth understanding that the Supreme Court of Pakistan in its judgment of 1987 clearly prohibit both the Provincial and the Federal Governments from taking over the properties. A few staff members are famous in making disturbance in the College, they instigate the students, disturb their education and deprive the students from their studies. They did the same with the previous Principal forcing him to leave the College. Unfortunately the Provincial Government instead of weighing and resolving the situation listening to the dissident staff, just 20 out 120-teaching staff.

The Diocese of Peshawar strongly feels that the High Court has been misled and deceived by the Government authorities. Moreover Government's biased attitude towards the Pakistani Christian Minority is also a violation of the Constitution of Pakistan. On one hand the PTI Government and its leadership claims to be the protectors of the Religious Minorities and their properties in Pakistan but on the other hand they are depriving the already deprived and marginalized minority from their Existence and Identity. The entire Church in Pakistan is sad and disturbed. Kindly pray for the Justice to prevail in Pakistan.
